MARRIAGE LICENSE AND CEREMONY FEES

Marriage license and ceremony fees are provided in 8 CMC § 1202 (a)(i) of 8 CMC § 1202 *et seq.*, as amended. Marriage license and ceremony fees for an applicant who is a resident of the Commonwealth of the Northern Mariana Islands (CNMI) and a non-resident of the CNMI differ.

As provided in 8 CMC § 1202 (a)(i), the following marriage license and ceremony fees apply to a resident and non-resident applicant.

Description	Resident	Non-Resident
Ceremony*	\$30.00	\$75.00
Marriage License Application	\$50.00	\$125.00

*Payment of ceremony fee is not required for marriage solemnized by a person other than the Mayor of Saipan.

The applicant must pay the applicable marriage license and ceremony fees, as marked in the box below.

Resident

Non-Resident

In addition, the applicant must pay the applicable fees for documentation and copy of the marriage license as provided in 8 CMC § 1202 (a)(i). The fee for documentation is \$25.00, and \$25.00 for a copy of marriage license. An applicant must pay the fees in the total amount of \$50.00.

Based on the review of application and documents submitted with the application, applicant must pay the total amount of \$_____. Payment must be made at any CNMI Treasury cashier located in Capitol Hill, Ground Floor, Joeten Dandan Commercial Building or Ground Floor, Guma' Hustisia (House of Justice) in Susupe, Saipan. An application must present the payment receipt issued by the CNMI Treasury to the Mayor of Saipan before a final decision is made on the application.
